In continuation of the earlier notification No. AHSEC/R&A/ADMN/2020/03/6563 dated 10/08/2021, following arrangements have been made in the greater interest of students:

1. In the interest of the students who have not been selected for admission in any of the institutions in which they had applied or the students who have not yet been applied for admission, the 'DARPAN' admission portal will be reopened from **20th September, 2021 to 22nd September, 2021** for them for submission of fresh application through the portal by visiting **www.darpan.ahseconline.in** or **www.ahsec.assam.gov.in** for admission in those institutions where vacancy is available.
2. Selection List and Waiting List for admission into HS First year will be prepared by the institutions concerned from **23rd September, 2021 to 24th September, 2021**.
3. Subsequent to preparation of Selection List and Waiting List by the institutions, AHSEC will make available the Selection List and Waiting List through the portal (**www.darpan.ahseconline.in**) for the students at **11 am of 25th September, 2021**. Further, candidates will receive a notification of their selection through SMS.
4. Concerned institutions will complete the admission process within **27th September, 2021 to 28th September, 2021**.
5. All the institutions will have to accept the admission in the portal using Institution Login ID on daily basis during admission process.
6. Candidates will be able to change their preferred subject(s) at the time of admission and the institution concerned will have to update the same in the portal on the day of admission.
